#### 3. BOARD CHAIR UPDATE

3.1 B. Turner provided an update on the status of the contract for the new Library Director, M. Taylor. He is still waiting on guidance from the City.

- 4.1 M. Taylor updated the board on Truth & Reconciliation initiatives, which include hiring the first Indigenous Storyteller in Residence (Jeremy Pahl) and the translation of library signage into Sm'algyax.

4.3 A large donation has been made to the Friends of the Library.

N. Purewal provided update on consultant interviews, which were conducted by M. Taylor over the summer. Motion put forward that the board hire Maynard Angus to guide the strategic planning process. M. Taylor has set up a meeting with CAO R. Pucci to discuss the facility's future and what the City of PR has planned.

- 6.1 R. Braun provided an update on the Microsoft Sharepoint account and its renewal. The business license has expired and we are now operating on a Basic license. There are still no fees for this service.
- 6.2 The board is in need of a new trustee. M. Taylor will follow up with city staff on advertising for applicants for the role. Discussion followed on how to best engage potential trustee candidates, the application process, how to make it more accessible, and what role the board plays in interviewing and recommending candidates. Policy Committee will research this.
